## **Notes to the Precept Budget**

### Note 1: Clerk's Salary:

The Clerk is currently paid for five hours per week (260 hours per annum) at point SCP 11 of NALC's pay scale. Having been Clerk since January 2014 the Clerk thinks it is not unreasonable to ask the council to promote her to at least SCP 12 on the NALC pay scale with effect from 1<sup>st</sup> April 2024. SCP 12 currently pays £13.73 per hour.

In January 2023 when the 2023/2024 Precept was set, the NALC pay scales operative from 1<sup>st</sup> April 2023 were not available – and indeed were not published until November 2023. In January 2023 Councillors therefore voted to award the Clerk a salary of £3,250 from 1<sup>st</sup> April 2023: this was based on 260 hours per annum on SCP 11 which paid £12.50 per hour. The NALC Pay scale published in November 2023 revised SCP 11 from

April 2023 to £13.50 per hour. Thus the Clerk, by 1<sup>st</sup> April 2024, will have been underpaid by £260 and requests that the £260 is added to her salary in March 2024.

#### Note 2 - Donation for Westhope Village Hall.

The Parish Council has since 2020 made donations to Westhope Village Hall Committee of £7,100: £2,100 from Precept funds and £5,000 from the Neighbourhood Fund. The Westhope Village Hall Committee now seek a donation in the region of £3,000 for exterior works, which will be debated at the DPC meeting on 24<sup>th</sup> January 2024.

#### Note 3 – Funding for the development of a public access playground in Diddlebury

Depending on the quotations received, it may just be possible to fund this from the Neighbourhood Fund, or with assistance from the school, although a small amount from the Precept Fund may be required. Grants and donations will also be sought.
