### Meetings

As it has not been possible to hold a Trustees meeting, I have produced this report to update trustees of appropriate issues.

It is hoped by June 2021 that we will be able to hold a meeting of the Trustees.

## **Financial Position:**

I attach a summary of the Income and Expenditure for the year 2020/21 (in Yellow) and the proposed budget for 2021/22.

The accounts for the Financial Year 2020/21 have now been completed and forwarded to the auditor for independent certification.

As of the 3<sup>rd of</sup> March 2021, the Trust had bank balances of £33,911.44 and share valuations of £67,043.

In respect of the Budget for 2021/22 I would suggest that there be no increase in the current rents and that we review next year.

# Repairs and Maintenance:

In accordance with the quinquennial survey, it is hoped that the following work will be undertaken this year.

- a) Replacement of the front doors to number 1,2 & 3 Estimated cost £3,500
- b) Party Walls in the roof areas to be extended for all properties to provide an appropriate fire wall for each property in the roof space. (Obtaining Cost)
- c) To completely re-roof the properties number 4 and 5 (Obtaining Cost)
- d) To investigate the requirement and extend of ground floor damp proof work required on each property. (Obtaining cost)

In respect of property 2 have provided the resident with additional storage boxes and would hope to agree with the resident some improvement works to the kitchen and Bathrooms.

### Independent Living Officer:

During this period of lockdown Mrs. Ann jenkins has continued to perform regular contact with all residents that require my support, whilst complying with current COVID restrictions and Government advice. This entails being based from home maintaining regular telephone contact and visiting sites when required whilst maintaining social distancing. It is apparent that the Pandemic has impacted greatly on residents and their lack of social activity.
